Requirements:

1. ALL INMATE TELEPHONE CALLS (LOCAL, LONG DISTANCE, ATTORNEY, ETC.) shall¹ be collect calls made at the expense of the person owning the telephone called, or by prepaid telephone debit minutes purchased from NCCRC by the Inmate making the call.
2. No credit card, three way, 1-800 or 1-900 calls are allowed. Call forwarding is prohibited and is subject to disciplinary action.
3. Telephones must be touch-tone phones.
4. All address changes must be communicated to the Chief of Security immediately or as soon as possible.
5. Reasons for calls being blocked:
 - After 30 days and no application has been received.
 - Called party pressing a 6 instead of 0 automatically puts a perma-block on the phone. Area code changed and or prefix
 - Securus Billing Department may block for high toil billing, unpaid bill, and daily limit (10 calls).
 - Three-way calling or fraud digit stop block.
 - LEC or Local Exchange Company has place a block.
 - HACTC has placed a block.
 - Called party called the Billing Department to block; their number. To unblock party requesting the block, you will have to call 1-800-844-6591 to have the block removed.
